Clearfield City Adopt-A-Trail Program

What is the Adopt-A-Trail Program?

The Clearfield City Adopt-A-Trail Program is a volunteer program providing opportunities for walkers, hikers, joggers and bicyclists to assist the park staff by monitoring, maintaining and enhancing sections of the Canal Trail or the Denver, Rio Grande & Western Rail Trail.

Who can adopt a trail?

School and youth groups, scout troops, church, community and service organizations, businesses, families, individuals or groups of individuals can adopt a trail. Anyone with an interest in trails and the outdoors is welcome to help preserve our land and provide safe, enjoyable access to the outdoors.

What can volunteers do?

Volunteers will assist the parks department staff in managing and maintaining the trails by committing to pick up litter a minimum of four times annually, or more if needed. Activities also include keeping the trail surface free of sticks, rocks and other debris. Volunteers will serve as an extra set of eyes for the Clearfield City Parks and Recreation Department to watch for downed trees/branches and to report maintenance and vandalism issues, trail hazards and safety issues.

Adoption Period

A trail or trail section must be adopted for a period of one year, renewable annually thereafter upon approval by the parks superintendent. The volunteer or the superintendent may terminate this agreement at any time.

Tools

Volunteers are asked to provide their own trail maintenance tools, but with prior notice, the parks department may have loaner tools available. The parks department has a supply of special refuse bags to be used for the Adopt-A-Trail program. The city will also provide pick-up of the bags when you are finished.

Recognition

Adopt-A-Trail signs will be placed on the trails to recognize those volunteers who have donated their time to keeping our trails clean and preserving this most valuable asset for the community.

Trail Regulations

- 1. Pedestrians have the right of way at all times.
- 2. Cyclists and skaters must travel at a safe speed.
- 3. Stay to the right except when passing.
- 4. Pass slower traffic on their left; yield to oncoming traffic when passing.
- 5. Be aware of your surroundings; give a polite verbal signal of your intent before passing.
- 6. Please pick up after your pets and keep all pets under control on a short leash.
- 7. As a courtesy to trail neighbors, refrain from loitering.
- 8. Please help keep your trails clean by picking up trash.
- 9. Absolutely no soliciting, sign placement, or advertisements of any kind will be allowed on the trail or its surrounding area (unless authorized by Clearfield City.)
- 10. Motorized vehicles are prohibited (except motorized wheelchair and authorized vehicles).
- 11. No drugs or alcoholic beverages allowed on trails or its surrounding area.
- 12. No smoking on trails or its surrounding area.
- 13. No fireworks of any kind on trails or its surrounding area.
- 14. All federal, state, and local laws apply.
- 15. Trails are open for use between dawn and dusk.
- 16. Areas of the trails may be under surveillance to assist in the prosecution of criminal activities.
